**Unsecured Permits:**

When work is started for which a permit is required, before a permit is secured, the permit fee shall be doubled. In cases where special investigation is required, an additional fee for on-site inspection prior to building permit review will be charged.

**Cancellations and Refunds:**

None granted after six (6) months from the date of issuance. Upon written request, prior to commencement of any work, permits may be cancelled by the holder and 70% of the permit fee will be refunded, except not less than **\$75.00** will be retained by the Township to cover administrative expenses.

In cases where work has commenced and a request for cancellation is received in favor of the permit to others, a fee of **\$75.00** shall be charged for each inspection made and the amount of the refund shall be based on 70% of the remainder of the permit fee, except as otherwise provided above.

**\*After twelve (12) months, and a permit has not been renewed, any bond will not be refunded\***

**Note:** Special consideration may be given in computing Plan Review fees for buildings, Such as large warehouses or indoor recreational facilities, due to their plan review simplicity. Such considerations may also be given to buildings with repetitive floor plans such as high-rise buildings.
